In addition, we may ask for consent to perform a credit or criminal record check or to obtain information from other private sources.

Applicants who are offered a unit must sign a tenancy agreement, and may be required to sign tenancy agreement addendums that cover topics such as pets, parking, laundry, smoking, crime-free housing, etc.
